Responsibility Declaration

I am responsible. When anyone, anywhere, reaches out for help, I want the hand of AA always to be there.

And for that: I am responsible.

If you are not alcoholic and attend open AA meetings, you are our guest, and should not take up any time during the meeting nor attend closed meetings. Sometimes, we need to be directed and told the way things are supposed to be.

The recent "Singleness of Purpose" articles have been interesting, yet there seems to be something lacking in them. The sponsor I had for over a decade, who died in 1995 with 30+ years of sobriety, would frequently express her concern that they are emptying out the psychiatric hospitals and rehabs into AA and that we are going to have to start having secret (invitation only) meetings to have real AA Groups. I hear that some AA's are actually having these secret meetings.

Her fear was that they would begin to outnumber us, who actually do qualify to be an AA member. (Refer to the conference approved Pamphlet – Problems other than Alcohol) Then they would be the majority and our Group Conscience would no longer be ours, it would be outside people posing as AA members, making decisions on how AA is run.

It is not their fault really, because they were misinformed by someone or are ignorant of the Tradition of our singleness of purpose. I believe that there is a purpose for everything that happens under our noses. I believe that some are meant to confront folks like us and I believe some are meant to just love others regardless of what there addiction is. But most I believe, we A.A.s need to practice Love and Tolerance while guiding those others who are not alcoholic to fellowships where they can be of help to others with the same malady they have. If you are not alcoholic and have some other sort of addiction and are only attending AA meetings, you

are a guest at our meetings and are welcome to gain perspective and to take what you can use for your own recovery. You may, at some point get a strong desire to share what you find here. To try to pass on recovery from other things or addictions here in AA at the meeting level is robbing precious time that is meant for sharing our experience, strength, and hope. This time is meant for alcoholics to help each other in the saving of our own lives and the lives of the alcoholics who may not get another chance to hear what they need to recover and live.

Another injustice that is happening to you is that you are denying yourself the privilege of help those others with addictions common with your own. (See the Cleveland pamphlet "If God would have spoken to AA, He might have said") [Available from akronaa.org

The power of AA is in its singleness of purpose and the One who has all power, that one is God. These Steps can help anyone to recover from anything they choose to use them to recover from. Yet here in AA we do not want to dilute the power of our singleness of purpose. This is the real issue of concern that causes all the controversy about other addictions/problems. The people who are just drug addicts or just food addicts or just "anything else" addicts trying to become AA members. They dilute the power for those of us who have the common bond, ALCOHOLISM. I am grateful that using these Steps have promoted freedom from alcohol. The Steps have also given me freedom in many other areas of me life. But when I come to an AA meeting I am there for a primary purpose: "To stay sober and help other alcoholics to achieve sobriety."

They had alternated Big Book and Step meetings with a speaker meeting once a month.

Special problem noted was the need to move location due to the death of the landlord. His widow did not wish

to continue to rent to the group.

Those First Three Steps

Only four months into my recovery, I have been asked to write my experience with the first three steps. After spending a week in contemplation of the change that has occurred in my daily perceptions, I write the following:

Step 1

I awoke at 5:00 AM on May 10th, after three days of consuming as much "good" wine as I could lay my hands on. I could not even contemplate mustering the strength to wait until the liquor store opened. I had nothing to drink. I could not go to work. I could not go to the gym to work out at 6:00 AM, as was my custom for the last four years. My life was 100% out-of-control! I was insane! Alcohol ruled my every thought! I was an alcoholic!

Afraid to leave the house, I stayed in bed or in "my chair" until Thursday. I shook constantly. I was terrified of the overwhelming desire to drink. I managed to get to the Doctor's office without stopping at the liquor store by waiting until I was going to be a few minutes late before chancing getting into my car. I was given a phone number for AA. In my car, in the parking lot, I called the number. The next, and nearest meeting, was 21/2 hours away, two blocks from my favorite bar and I was going to need to pass the liquor store. The man on the hotline told me to drive "the long way around" and miss the liquor store. I did as I was told and sat outside the meeting until people started to arrive. I needed help! I could not manage my life. I could not manage a day of my life.

Once inside, in the candlelight, I admitted, aloud, to others, and myself that I was an alcoholic and needed help. I needed someone or something to take control of my life.

Step 2

The realization that no human power could relieve my alcoholism and restore me to sanity took some time. I had to look back after several months of sobriety to realize the all consuming desire to drink no longer haunted my every minute. I did not carry myself through those days. I could not have done so.

The first few weeks are a blur. Only the love of my Grandmother, whom I initially nominated as "a power greater that myself," and God could have carried me. I spoke with my Grandmother constantly, praying. One dawn, as I sat on my porch at sunrise, as I often do, I discovered God. The God of the sunrise, the sunset and the tides, whom I have worshipped since my childhood, but had never found outside of Cape Cod. For that matter, I had not realized that the strength that I gleaned from the Cape was God.

Step 3

In many ways, turning my life over to the care of God has been an easy choice. The controlling stubborn person who ran my life failed miserably. I will be tested, of this I am sure. But for now, this minute, my future is in God's hands. Hope pervades my existence. Life pleases my spirit.

I must learn to accept God's grace.
