Old Business

Motion made by Steve P: Requesting an annual budget line item of \$1200.00/year to restock and continue the work of the committee. Motion tabled until next meeting.

Re-opened for discussion – Question was asked: What is the districts representation? Districts 66 and 67 does not have a PI/CPC. District 33 does have a subcommittee, albeit very small. The annual proposed budget was asked to be reviewed by the IGR. Response: Total

spent is \$1500 in 15 months and \$1100 came from intergroup. The balance was private donations from committee members. Materials will need to be re-supplied to use at events. There are future events planned as outreach. School outreach would require funds as well. If there is a budget, the committee can plan out the year accordingly. Re-stocking all material is about \$150. About 12 events a year. Have handed out 6,000 business cards and have given out books and bracelets out to district justice and libraries, doctor offices. A member stated that this is a great use of funds, but we do have a cash flow problem and was suggested that districts send funds to assist. Can we have a breakdown of where the money has been spent thus far from the committee?

Motion made to table this vote until next month and second. Must pass by simple majority. 15 yay and 17 nay
