## Archives - Robert P (Email: Archives@ReadingBerksIntergroup.org )

- 1. Completed:
  - a. Storage unit (5' x 5') Arrow Storage on Sofianos Drive next to the Amazon Fulfillment Center.

i. In September 2024, the monthly cost increased from \$26.50/month to \$37.10/month. The resulting annual cost increased by \$127.20, from \$318 to \$445.20. This is still well-below standard rates for Arrow Storage and a couple other local storage facilities that I checked.

ii. Storage unit was cleaned, and contents were consolidated. I have not thrown anything out. At the December RBI meeting the previous Archives servant reported that the unit was full. Our storage unit utilization is less than 50%. Most of the contents is party/picnic supplies, rather than Archives. Before and after photos are below. In the "after" photo, the bins/boxes on the left are all party/picnic supplies. The 4 bins in the middle of the unit are for Archives.

- iii. Space is available for other committees/servants.
- b. Archives bins Initial high-level review of contents is complete.
- c. Digitization One of my goals for 2025 is to begin the process of digitizing our archived material, so that our history is more readily available to the local community. I have had Initial communications with Sam, our website servant, on this matter.
- d. Early Berks County AA History in newspapers I have subscriptions to archived newspapers, and the Reading Eagle is one of the newspapers available. I have begun reviewing Reading Eagle articles that include the words "Alcoholics Anonymous". I'm up to the early 1950's at this point.
- 2. Next Steps
  - a. Request to establish ad-hoc Archives committee to execute the following next steps. The more people we can get involved, the faster these initiatives can be completed.
  - b. Conduct a thorough review of storage unit bins' contents to improve organization and determine what to retain in paper copy.
  - c. Determine which documents to digitize and add to website, and the related prioritization. Define scope for phase-one additions to website.
  - d. Request permission from newspaper website owner(s) to include copyrighted articles on RBI website.
  - e. Update Home Group documentation and history. Collaborate with RBI visitation chair as needed.
  - f. Complete phase-one additions of Archives to RBI website.
  - g.
